

Dr. Pewewardy explores postcolonial Indigenous research paradigms to understand the lingering impact of colonization. Dr. Pewewardy seeks to advance policy and practice that address persistent racial and socioeconomic inequities within Indigenous education, and that reflect the voices and expertise of historically underserved families and communities. He works to advance the education of Indigenous students and explore university-tribal relationship-based pedagogy.

He continues to serve through professional associations including the City of Lawton Race Relations Commission and as Founder of the Comanche Academy Charter School and Founder of Indigenous Peoples' Day in Lawton (OK), among others.

She was also an Oklahoma County Assistant Public Defender, specializing in pre-trial/bond matters. In these positions, Francie provided program management, legal representation, and advocacy to individuals encountering the Oklahoma County criminal legal system.

From 2019 to October 2021, Francie served as a Trustee of the Oklahoma County Criminal Justice Authority, addressing issues surrounding the Oklahoma County jail and chairing an Action Committee.

She is a graduate of the University of Oklahoma where she earned a BS in Arts and Sciences, a MA in Human Relations, and was a varsity volleyball student-athlete. She also holds a juris doctorate degree from DePaul University College of Law. Currently, Francie is an adjunct professor at the University of Oklahoma, instructing undergraduate, graduate and accelerated graduate level students in the Human Relations Department.

A devoted advocate for children of incarcerated parents, Francie served on the Oklahoma Messages Project Board of Directors from 2014 to 2022. She also served as an honorary guest of the Oklahoma Commission on Children and Youth's Children of Incarcerated Parents Advisory Committee. She is a proud member of Leadership Oklahoma Class 33 and Leadership Oklahoma City Class 36.

Jabee Williams | CEO, LiveFreeOKC



Jabee is an Oklahoma City-based community organizer, educator, entrepreneur, and artist who is dedicated to the well-being and liberation of Black people. One of six children, Jabee grew up in a single-parent family on the East side of Oklahoma City. Experiencing homelessness and the hardships of poverty as a child, Jabee turned to music to cope with difficult experiences, including the shooting death of his little brother, Junie. Music grew from an outlet of expression into a passion and then career for Jabee.

A highly respected recording artist embraced by the rap and hip-hop industry as a creative trendsetter within the genre, since 2008, Jabee has released several critically acclaimed music albums and performed

before audiences in a variety of musical venues. The latest album, "This World Is So Fragile and Cruel I'm glad I got" debuted #3 on iTunes music charts and stayed in the top 10 for over a month. In 2021 Jabee started a nonprofit with the OK Mural Syndicate called "With Love" that advocates and creates public art on the Eastside of OKC. In 2022 and 2023, Jabee and partners opened Eastside Pizza House and Scrambl'd, respectively. Both restaurants are located in the heart of OKC's Black community, a food apartheid. The restaurants are Black-owned and staffed by people from the Black community. The restaurants also provide critical community gathering spaces, frequently hosting community conversations and celebrations.

In the spring of 2022, Jabee partnered with Pastor Mike McBride to co-found LiveFree OKC, and successfully launched Oklahoma's first violence intervention program, serving Oklahoma City's Black community. Jabee continues today as the Executive Director of LiveFree OKC pursuing a mission of peace and reduced violence in Oklahoma City.

Jon Middendorf | Senior Pastor, OKC First Church





He served on the state board of Big Brothers Big Sisters and as board chair for a nonprofit school for children of incarcerated parents. He also created a foundation to support students at the Phoenix Rising Alternative School in

Tulsa.

Kris Steele | Executive Director, The Education and Employment Ministry



Kris Steele is Executive Director of TEEM (The Education and Employment Ministry), a nonprofit dedicated to breaking the cycle of poverty and incarceration in Oklahoma.

Kris currently serves as a member of the Pardon and Parole Board and as a Trustee of the Sarkeys Foundation. He also serves as the Chair of Oklahomans for Criminal Justice Reform, a coalition of community groups, business leaders, health professionals, and faith leaders dedicated to advancing effective approaches to public safety by increasing access to treatment and programs designed to address root causes of crime.

Prior to joining TEEM, Kris served as State Representative from 2000-2012, and Speaker of the Oklahoma House of Representatives for

the 53rd Legislature. During his tenure in office, he led the charge on a number of reforms in the areas of health care, human services and criminal justice. Kris earned a BA in Religion from Oklahoma Baptist University, and a MA in Education from East Central University.

Kym Cravatt | General Counsel, Department of Health, Chickasaw Nation



Kymberly D. Cravatt served as the Assistant Director for Prosecution in the Office of Tribal Justice Administration for the Chickasaw Nation. Her primary assignment was to oversee the implementation of the Nation's expanded prosecution duties following the United States Supreme Court's historic *McGirt v. Oklahoma* decision and the *Bosse v. Oklahoma* decision from the Oklahoma Court of Criminal Appeals. Recently, Ms. Cravatt became the first General Counsel for the Chickasaw Nation's Department of Health.

Ms. Cravatt is a graduate of the Oklahoma City University School of Law (OCU) where she earned a Juris Doctorate and a Certificate in Federal Indian Law. Ms. Cravatt also holds a Master of Public Health degree from the University of Oklahoma College of Public Health and has more than two decades of experience working for tribal health programs.

Ms. Cravatt is admitted to practice in the Supreme Court of Oklahoma, the Chickasaw Nation Supreme Court, the Seminole Nation Supreme Court, the Muscogee (Creek) Nation Supreme Court as well as the Eastern District of Oklahoma. Ms. Cravatt is a former Chairperson of the Chickasaw Bar Association and serves as a Director for Oklahoma Indian Legal Services (OILS) and currently serves the Board of Directors as Secretary.

Leslie Osborn Oklahoma Labor Commissioner



In 2022, Leslie Osborn was elected to a second four-year term as State Labor Commissioner. Prior to that, she served ten years in the OK House of Representatives for District 47, where she was the first woman to chair the House Judiciary committee, and the first Republican woman chair of the House Appropriations and Budget Committee. She authored landmark workers compensation reform and passed into law the first Pay for Success contract in Oklahoma, a public-private partnership with the Department of Corrections and the Kaiser Foundation to move women from incarceration to the Women in Recovery Program.

Osborn received a B.S. in business administration from Oklahoma State University and resides in Mustang, Oklahoma. Leslie owned and operated her own business for 22 years selling heavy duty truck parts, Osborn Pick-Up Accessories, and is the mother of two children.

Osborn serves on the advisory board of *OK Small Business Development Centers, Youth & Family Services of Canadian County* and the *Oklahoma Academy.* She is the President of the Board of *Honestly to Prevent Teen Pregnancy*, and the *Canadian Valley Technology Center Foundation*.

Luke Cantrell is a junior majoring in economics and psychology at USAO college in Chickasha, Oklahoma. Luke grew up in Shawnee, Oklahoma his entire life and hopes to work for a nonprofit organization or in any field that genuinely helps people. Melvin Battiest | Founder, Native Wings Like an Eagle



Melvin Battiest is an enrolled member of the Muscogee Nation of Oklahoma. He currently serves as the Executive Director of the organization Native Wings Like An Eagle Inc. This organization was established to partner and collaborate with all 39 tribal nations in Oklahoma to provide reintegration services to enrolled tribal members who choose not to return to the reservation upon their release from incarceration. Reintegration services are so vital for the individual who has served time and seeking to be an asset to their community upon their release. Within the Native approach to reintegration, cultural programs are essential for a successful return of tribal members and such programs are not available off the reservation. Native Wings was created to help fill this gap for tribal members who need a new beginning in a whole different environment. After serving 38 years of incarceration,

Melvin found that reintegration services from his tribe were not available due to living off the reservation. This was unexpected and Melvin did not want to see other Native men and women experience what he did. Melvin's passion is helping Native men and women post incarceration to receive their much needed help.

Mimi Tarrasch | Chief Program Officer for Family and Children's Services



Mimi Tarrasch has been Chief Program Officer for Family & Children's Services Women's Justice Programs for 14 years. She is committed to providing alternatives to incarceration, supportive services, and advocacy for women entangled in the criminal legal system. She works closely with the criminal legal system and community agencies to provide comprehensive women's services including substance use and mental health treatment, education and workforce training, health and wellness services, housing, intensive case management, and parent-child reunification.

Mimi has a proven history of organizational leadership during her 29 years at Family & Children's Services (F&CS). Prior to addressing the

state of Oklahoma's high rate of female incarceration, she dedicated over a decade to enhancing early childhood education in Tulsa and developed the F&CS Early Childhood Education division.

Ololade Yerokun | Freshman, Langston University



Ololade Yerokun is a freshman, but classified as a junior, at Langston University in Oklahoma, where she is majoring in General Studies, Criminal Justice, B.S. in Corrections and B.A. in Sociology. Olalade graduated high school with an Associate degree in Arts of Multidisciplinary Studies. Olalade hopes to attend law school and possibly pursue a masters' degree, with the hope of becoming a prosecutor. Olalade's hobbies are sewing, cooking, reading, and watching anime.

Reggie Cotton | Deputy Chief, Muskogee Police Department



Deputy Chief Cotton was born and raised in Muskogee, Oklahoma. He has worked with the city of Muskogee for more than 30 years, and is currently the commanding officer for the Administrative Division. He has served as a police administrator for the department since 2004.

Cotton graduated from C.LE.E.T. in 1990 while serving as a patrolman

Yvita Crider | Square One Consultant and Project Co-Lead



Yvita Fox Crider is an Independent Consultant with the Fox Crider Consulting Group and co-chair of the Oklahoma Square One Project. Her previous work in Oklahoma included serving as the Director of Statewide Engagement for Oklahomans for Criminal Justice Reform as well as leading a task force of educators to research Oklahoma's juvenile justice system and propose recommendations for its improvement and population reduction. Before transitioning to the reform sector she was an educator and served as the Director of Leadership Development and Policy for the Oklahoma City region of Teach For America. Her work involved advocating for the equitable access of marginalized communities to high-quality education and training educators to more effectively address harmful systems and policies affecting their classrooms and the communities in which they serve. Yvita transitioned to the justice reform arena when she

led a task force of educators to research Oklahoma's juvenile justice system, propose recommendations for its improvement, and reduce its population. Since then, Yvita has been active in justice reform work in her community and is an appointed member of the 2021 Citizens Advisory Board for the Oklahoma County Jail.
